## Can we ask you to do just one more thing and help even more people?

## Is my donation eligible for Gift Aid?

If you are a UK tax payer **YES**

Even if you are not employed you are still eligible if you are paying tax on any of the following:

- ✘ Personal or occupational pension
- ✘ Savings (in a bank or building society for example)
- ✘ Stocks and shares
- ✘ Rental Income
- ✘ Overseas and UK investment dividends
- ✘ Capital gains tax (from the sale of assets like a house or shares)

## Am I committing myself to give regularly?

No. Signing up for Gift Aid does not commit you to further donations but any you do give, will be covered by the declaration.

## What should I do if I move house or change name?

Please let us know if any of your circumstances change so that we can keep our records up to date.
