Online learning platform about palliative care

About the training

As a health and care system, our aim is to provide consistent End of Life Care (EoLC) training to achieve consistent learning outcomes (LOs) for all health and social care professionals working across Northern Lincolnshire, who are involved in the delivery of EoLC.

In an attempt to respond to educational challenges brought about by the scope of the work and changes in education delivery during the COVID 19 pandemic, our challenge is to develop high quality, accessible education for staff that are committed to delivering excellence in care to patients at the end of life.

We are offering both online training and face to face training outlined in this directory.

Host / facilitator

We have taken advantage of the Health Education England e-learning for Healthcare's (HEE e-LfH) End of Life Care (e-ELCA) e-learning programme to develop a local learning path. Lindsey Lodge Hospice have taken a lead partner role with the co-ordination of this work and an education and training EOL subgroup involving partner representatives has contributed and shared in both design and content.

Learning outcomes (LO) achieved

For priority training, we are using learning outcomes produced and implemented in other areas, published by NHS Health Education England. These have been developed by an expert group to improve the standards of EoLC delivered across the Yorkshire and Humber region.

The EoLC LOs were produced in the context of on-going national policies and recommendations for EoLC and were updated in October 2019.

They have been extensively tested and evaluated, and positive feedback has been received, which demonstrates:

- 1. The EOLC LOs are flexible, enabling them to be tailored to individual professional roles
- 2. Evidence can be used towards professional revalidation
- 3. Learning/development related to the LOs is achievable within current workloads
- 4. The EoLC LOs can assist organisations with succession planning, service, and staff/career development
- 5. The EoLC LOs can inform pre-qualifying and post-qualifying curriculum development.

The framework adopted defines the learning outcomes for EoLC. These have been developed for each staff grade. They should be used to support your workforce through their education and personal development.

It is recommended that the EoLC LOs are used to provide a common language for EoLC, to enable consistency and sustainability in education and training and for professionals to demonstrate learning that is transferable across settings and organisations. As a system working across Northern Lincolnshire, we have chosen to focus on the HEE End of Life Care Learning





















Outcomes Sub-sets for One Chance to Get it Right and for 'mandatory or priority' EoLC education and training.

All EoLC LOs are organised using four key themes of clinical/professional practice:

- 1. Clinical / direct patient care
- 2. Leadership and collaborative practice
- 3. Improving quality and developing practice
- 4. Developing self and others.

No booking is required for access to the virtual education and training.

All you need to do is register with <u>Futures NHS</u> and <u>E-Learning for Health</u>, it's free and you can access the programmes at any time.

Some organisations using ESR e.g., Northern Lincolnshire and Goole NHS Foundation Trust and Care Plus Group, you will be able to access directly through your internal ESR system.

As you complete online training, you will be able to download a certificate that you can offer your line manager for your personal staff records.

Other non-priority training

It is recognised that face to face learning is desirable to some staff and therefore this learning directory offers you access to more EoL continuing professional development (CPD). You can access this training, delivered by differing facilitators at different venues, should a space be available. Remember, where no dates are specified, it is because the facilitator is waiting for sufficient interest to make the session viable - please register your interest and the facilitator will contact you.

We hope you find the training and education useful to your role and helpful to you in your care for patients and their loved ones.

Domiciliary care: supporting those at the end of life

About the course

A one-day course to enable workers who support and care for people, and their families who are approaching end of life or have palliative care needs to provide care of the highest quality.

- An understanding of the 5 priorities in EoLC
- Recognise the likely symptoms of the dying process
- Identify the communication skills required to communicate effectively with a person at the end of life

- Be able to recognize the impact that loss has on individuals and how to offer support.

Registered nurse study day

This study day lasts 7.5 hours and it is mandatory for NLaG staff who are required to attend every five years.

About the course

The course content is as follows:

- To have knowledge of the National and local drivers
- Discuss care in the last days document and its importance
- Know where to access Policies and Legislation
- Advanced care planning
- Feel empowered to discuss clinical decisions
- Discuss the importance of Patient and Family Support.
- NLAG Strategy and Outcomes 2021-2026 incorporating the Six Ambitions
- End of Life Strategy (DOH 2008)
- The Five Priorities of Care for the Dying Person (2015)
- Leadership Alliance for the care of the dying person (2014)

Learning outcomes

- Interpretation of the National Palliative Care and End of Life Framework and how it is used
- Interpretation of the requirements of the local end of life strategy

- Understanding of trust policies relating to EoLC
- How to make clinical decisions and act as the patients advocate
- Understanding of the priorities of the dying person.

Syringe driver and symptom management

This study day lasts three hours and it is mandatory for NLaG staff who are required to attend every two years.

About the course

The course content is as follows:

- · The registered nurse's responsibility and accountability
- Indications for use
- Support of both patient and family
- Pre-operational inspection of the machine
- Demonstration via video of the safe and effective preparation of the machine and syringe and effective use by monitoring the infusion
- Management of changing a new syringe / end of infusion
- Knowledge of the appropriate policy for procedure for the use of the McKinley syringe pump in palliative and EoLC
- Common symptoms that occur at the end of life
- Common drugs used in the syringe driver for palliative and end of life patients
- Converting drugs from oral medication to the subcutaneous route
- Direction to useful documents / resources.

Learning outcomes

- The role and responsibility of the registered nurse regarding syringe drivers
- Identifying indications for use
- Guidance for patient and family
- Pre-operational inspection of the machine
- Understanding safe and effective preparation of the machine and syringe, and effective use by monitoring the infusion
- How to change a new syringe / and how to end an infusion
- Understanding of the appropriate policy/ procedure for the use of the McKinley syringe pump in palliative and end of life care
- Identifying common symptoms that occur at the end of life
- Understanding common drugs used in syringe driver for palliative and end of life patients
- How to convert drugs from oral medication to the subcutaneous route
- Direction to useful documents / resources
- To have knowledge of when to commence a syringe driver
- To be confident in setting up and using a syringe driver
- To be aware of common issues with a syringe driver and how to address these.
